## SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Carcinogenicity (Category 1). May cause cancer (H350). Obtain special instructions before use (P201). Do not handle until all safety precautions have been read and understood (P202). Use personal protective equipment as required (P281).



Hazard class: Acute toxicity, oral (Category 4). Harmful if swallowed (H302). Do not eat, drink or smoke when using this product (P270).

## SECTION 4 — FIRST AID MEASURES

Flinn Suggested Chemical Storage Pattern: Inorganic #2. Store with acetates, halides, sulfates, sulfites, thiosulfates and phosphates. Hygroscopic. Store in Flinn Chem-Saf™ bag. Store in a cool, dry place. Use only in a hood or in a well-ventilated area.

Wear protective gloves, protective clothing, and eye protection. Wash hands thoroughly after handling (P264). Contaminated clothing should not be allowed out of the workplace. In case of inadequate ventilation, wear respiratory protection (P285).
